

VOLUNTEER WAIVER OF LIABILITY

PLEASE READ CAREFULLY. THIS IS A LEGAL DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS.

THIS RELEASE AND WAIVER OF LIABILITY (the "Release") executed on (DATE) _____, 20_____, by _____ (PLEASE PRINT NAME) in favor of Bay Area Recycling for Charities, a nonprofit organization and its directors, employees and volunteers (collectively "Releases"). The participant desires to volunteer at programs and activities conducted by Bay Area Recycling for Charities. As used in this Release, the terms "volunteer", "participant", and "participation" are intended to be used in the broadest sense and shall include any and all activities of any kind of nature, at any time and in any place that is performed by the participant with Bay Area Recycling for Charities.

Participant hereby consents to participate as a volunteer in Bay Area Recycling for Charities activities. In consideration for the opportunity to volunteer in and to participate in Bay Area Recycling for Charities activities, Participant does hereby freely, voluntarily and without duress execute this Release under the following terms:

1. Waiver and Release. Participant does hereby release and forever discharge and hold harmless Bay Area Recycling for Charities and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participation. Participant understands that this Release discharges Bay Area Recycling for Charities from any liability or claim that the Participant may have against Bay Area Recycling for Charities with respect to any bodily injury, personal injury, illness, death, disability, property damage, incidental or consequential damages, punitive damages or special damages that may result from participation, whether caused by the negligence of Bay Area Recycling for Charities or its employees, directors, or other Bay Area Recycling for Charities volunteers, or otherwise. Participant also understands that Bay Area Recycling for Charities does not assume any responsibility for or obligation to provide financial aid or other assistance, including but not limited to, medical, health or disability insurance except as Bay Area Recycling for Charities has specifically disclosed in writing to the Participant.
2. Medical Treatment. Participant does hereby release and forever discharge Bay Area Recycling for Charities from any claims whatsoever which arises or may hereafter arise on account of any first aid, treatment or service rendered by any person in connection with Participation.
3. Assumption of the Risk. Participant acknowledges that there are potential hazards ("Hazards"), known and unknown, involved in Participation. The term "Hazards" is intended to be used in its broadest sense and includes, but is not limited to natural hazards (land, weather, etc.) and man-made hazards (concrete, steel, etc.), food contamination, and as well as hazards typical for playing gaming equipment and competitive games. The Participant understands and acknowledges that participation may include Hazards that could harm the Participant, and that such Hazards may or may not always be obvious. Participant hereby expressly and specifically assumes the risk of injury or harm for all such Hazards and Releases Bay Area Recycling for Charities from all liability for injury, illness, and death or property damage resulting from Participation.
